The announcement was followed by an engaging and captivating panel discussion on The Future of Volunteering- Be the change you want to see, which included eminent panelists who form the Awards Jury for the Mumbai region.

The awards competition will be held regionally in four zones of India, including Mumbai with shortlisted candidates being eligible for the national round of selections. The grand finale will be held in New Delhi on August 2011, judged by a prominent National Jury. The awards hold a special significance in its commencement this year since the United Nations is celebrating the 10th anniversary of the International Year of Volunteering globally.

#### The Award Criteria includes:

Demonstrated benefits to the community/organisation along with evidence of initiative and innovation

Commitment of the volunteer, sustainability of the work after the volunteer has left and the length of service and number of hours of spent volunteering
