endowed with rich and diverse forest resources. It is a reservoir of biodiversity. The geographical area of the state is 308,144 km<sup>2</sup> which constitutes 9.38% of the land area of the country. The forest area of the state is 95,221 km<sup>2</sup> constituting 31% of the geographical area of the state and 12.44% of the forest area of the country.

One third of the state is forested and offers a unique and exciting panorama of wildlife. In the National Parks of Kanha, Bandhavgarh, Shivpuri and many others one has the rare opportunity to see the tiger, the bison and a wide varieties of deer and antelope in sylvan surroundings. Nine National Parks and Twenty Five Wildlife Sanctuaries are attractive destinations on tourist map.

Madhya Pradesh Forest Department is engaged in protection, conservation & management of largest forest area of the country. Economy and livelihood of about 9.5 million tribals of the state is inextricably linked with forests. Forestry operations provide 40 million man-days of employment every year. Forests of MP are critically important for catchment area of important rivers like, the Narmada, the Chambal, the Betwa, and the Sone etc. The State is pioneering the JFM movement for conservation of forest resources through people participation.

### **Call for Abstracts and Papers**

Prospective authors are invited to submit abstracts of papers for presentation at technical sessions of the Conference. All abstracts should be written in English comprising 300 - 500 words. These abstracts will be reviewed for selection for oral and poster presentations. The deadline for abstract submission is 30 September 2011.

Each abstract must contain sufficient details for evaluation (including the approach, results, the concepts and the reasons why it should be considered an interesting message for the audience).

Author(s) must select 5 - 8 keywords.

Authors must indicate clearly on the Abstract Submission Form to which session the paper is intended (Abstract Submission). The presenting author (corresponding author) also must be clearly indicated. A participant may be the co-author of multiple papers; however, each author may present only one paper at the Conference.

Full papers must be prepared according to the Guidelines for authors. Authors are requested to follow the Manual for presentation of Technical Papers at the Conference and sessions. The details are available at conference website: www.nwfpcon.com

Information about the status of acceptance of the papers will be sent to the authors not later than 10 October 2011 by the Conference Secretariat. Full paper will be due on 30 November 2011. Payment of the registration fee by the presenting (corresponding) author must be made prior to the deadline of 25 November 2011. Accepted papers received from registered participants by this date will be published in the Souvenir of the Conference.

Abstracts and full papers should be submitted online at the Conference website www.nwfpcon. com. Corresponding author will be informed of the acceptance of their paper by 10 October 2011.

Conference Books/Papers shall be published in paper and digital format and widely distributed forestry research and policy making organization. Delegates will receive a copy of the book in paper or digital format at the time of registration. Papers are also archived at http://iifm.com
