TERMS AND CONDITIONS

- 1. Expression of Interest/ Proposals are invited from the interested Service providers/accredited agency for adoption & certification of organic farming in Vegetables and Litchi fruit orchards areas of Bihar at farmer's level and related activity, as well as training to the identified government agency towards adoption, certification and marketing of organic produce.
- 2. The agency will be required to facilitate group organic farming for conversion of conventional fields/farms to organic, ensure necessary technology transfer as well as supply of organic / Bio-inputs to farmers, ensure necessary documentation with the help of the identified accredited agency and ensure organic certification with ensured market for the certified organic produce.

3. Eligibility:-

- Agencies having at least 3yrs accreditation under APEDA for certification of organic produce. They shall have to furnish the requisite documents in this regard.
- Applicant organizations should have valid three years' Annual reports and audited balance sheets i.e; from 2008-09 to 2010-11.
- Agencies should have at least 5 yrs experience in organic farming, farmer's group formation, organic certification /Global Gap Certification and internal control system management applicable for grower group certification scheme of food.
- Company should have ISO certification.
- Annual Turn over of the company should be atleast `0.5 Crores.
- Company should have experience of implementing such projects for atleast two states in Horticulture Deptt.
- Company should have experience and manpower on the Adoption and Certification of Organic farming & Global Gap Certification supported by documents.
- 4. The selected agency will be required to perform the task as under:
- a) Organic farming/Global gap for conversion of conventional fields / farms to organic should ensure necessary technology transfer to farmers and ensure necessary documentation.
- b) Motivation meetings, orientation programmes for farmers, package of practices for organic farming,
- c) Supply of organic inputs to farmers essential for this adoption.
- d) Formation of farmer's clusters, Registration of farmers, Setting-up of Internal Control System (ICS) and Maintenance of field records (cultivation measures, cultivation problems, pest and disease incidence and control, use of inputs, harvested quantities, post harvest procedure)
- e) Drawing of cluster map, Registration of Growers.

- f) Getting accreditation from APEDA.
- g) Carrying out training and exposure visit programmes of farmers as well as the officers/ staff as per need based basis.
- h) Certification of organic produce of all the registered farmers within time in approximately 500 ha of specified Fruits and vegetable area in Bihar for at least NPOP, NOP & USDA.
- i) Providing assistance in packaging and storage of the produce and arrange processing, transport and sale of organically certified produce.
- j) Any other related activity with organic farming & marketing in the area.
- 5. BHDS will not be responsible for any postal or other delay in receiving the expression of interest.
- 6. Earnest money of Rs. 50000.00 only payable through demand draft of any scheduled bank in favour of "Mission Director, Bihar Horticulture Development Society, Patna, Payable at Patna, should be submitted along with EOI. Proposals not accompanied with earnest money shall be summarily rejected.
- 7. The interested bidders should submit the following documents/ details in support of their claims:-

- Annual reports showing details of organic farming programmes performed during last three years.

- Proof of 3 years experience in the field of organic certification.
- Copies of literature, paper cuttings, publications etc. published by the organization on organic farming/natural agriculture or sustainable agriculture.
- Undertaking Bond duly filled up & signed on Rs. 100/- non judicial stamp paper
- Demand Draft of EMD
- 8. For Training on Production and Quality Control etc, please specify that the organization have adequate technical persons capable of conducting such course and have necessary laboratory facilities for technology demonstration.
- 9. Only registered firm will submit EOI tender on prescribed Format (download from www.horticulture.bih.nic.in) and firm should be registered where ever applicable.
- 10. The successful bidder will be paid Rs. 10000 (Ten Thousand) per ha in mutually agreed time phases in instalments of 40:40:30 ratios in three years of certification, for the aforementioned total assignment. All type of taxes, charges are included in this amount and nothing additional would be payable except this amount.
