### III) FAQs

### How do I fill the entry form?

Applications can be submitted only through the online application form. Start from Part 1 and fill up each part, following the examples and instructions. It may be advisable to download the PDF version, take a print out, fill it up in consultation with your colleagues and use that to finally make the submission online. This will be especially needed if your Internet connection is unsteady.

### Can I send multiple entries?

You can send in multiple entries only if you are applying for an award in multiple sectors or for more than one primary activity. For example: if your NGO works in health and education, you can apply for an award in both sectors – but you will have to fill up two separate entry forms.

### How does the nomination system work?

If A wants to nominate B, then A will fill up the online nomination form (with minimal information) and submit it. This will trigger an automatic communication alert to B. Then B will fill up the application form and submit it online. This application form will then join the direct applicants' stream.

### Who can apply or be nominated for the awards?

Three types of nominations/applications are acceptable:

- 1. **Non-Governmental Organisations (NGOs):** Trusts or societies registered under the relevant act in India and currently functioning in India. NGOs set up and primarily funded by corporate bodies are not covered in this category.
- 2. **Corporate Bodies:** Any corporate body or an entity set up by it as a society/trust, currently functioning in India.
- 3. **Government Departments:** Any state or district level unit of a state or central government department/ministry, through its head or through a person in a responsible position.

What categories of work are eligible for awards?

Current ongoing initiatives will be considered for the award. Awards will be given for the five categories mentioned below. As examples, some types of activities are listed in each category.

- 1. **Education**: Examples: education of underprivileged, or challenged children; improving access or quality of education; teachers' training; development of teaching aides; development and spread of curricula; vocational or technical education centers; education in special fields like sports or music, etc.
- 2. **Health**: Examples: provision of low cost healthcare; provision or facilitation of basic healthcare to underprivileged sections; encouraging hygiene and other healthy practices; creating infrastructure for these; etc.
- 3. **Livelihoods**: Examples: any self sustaining economic activity leading to income augmentation and employment creation, especially for under privileged sections like women, dalits, tribals; skill development; training in technologies
- 4. **Environment**: Examples: activities that limit air, water, noise pollution, emission of GHGs; conservation of bio-diversity; conservation of forests and green cover; conservation of wild life; etc.
- 5. **Awareness Generation**: Examples: creating awareness about all the above issues; creating awareness about women's rights, RTI, legal rights, social evils like dowry; creating awareness about national integration and religious tolerance; etc.

In case your work spans two or more issues, choose the category that represents maximum social impact. Alternatively apply for more than one category, but remember you will have to submit separate application forms for each category.

### What is 'primary activity'?

In case your organization is involved in several kinds of activities within a sector, decide on one main or primary activity for which this award is sought. This activity may be the one with widest impact and crucial to your overall work. Details only about this activity need to be filled in except when otherwise asked. Example: you are running a primary school for children of migrant labor. Also, you are giving after-class tuitions to some of the children, and giving scholarships to some, and you have just started teaching their mostly illiterate parents. You should choose 'Education' as the Sector and "Delivery of education to children of vulnerable sections" as the primary activity. You can mention the rest of your activities in 'Other Activities'.

### How will the awardees be chosen?

All entries will be screened to eliminate incomplete or wrongly filled ones. Our process partners will sort and categorise the entries. Then, a panel of experts in various sectors will grade the entries according to selection criteria. The top 10 entries in each sector will go to the Jury, along with inputs from experts. If necessary field visits will be undertaken for final evaluation. The Jury, after due deliberation, will select the final awardees.

### Will the selection process be transparent and unbiased?

Completely. Names and key details of all entrants will be uploaded on the award website. At each stage, those eliminated and those progressing further will be suitably marked. You can track the progress yourself. The winners' names will, of course, be announced in the print edition too.
