CONTEXT

The System of Rice Intensification (SRI), developed in Madagascar some 25 years ago, is gaining increasing credence and momentum as probably 500,000 farmers in more than 20 countries are now using its methods to raise their rice production. Many of the traditional voluntary organizations especially the first and second generation ones, have experimented and have found SRI technology to be successfully proven in field.

Within SRI's conceptual and practical framework, farmers have devised many innovations.

SRI works by changing the management of the plants, soil, water and nutrients utilized in paddy rice production. However, a professional, systematic approach and economic orientation is needed to work on the Cultivation issues of the SRI technology that requires economic and market orientation. This calls for a shift in the perspectives, processes and systems to understand the development programmes in the Agriculture sector.

This training is being offered for promoting exchanges with the participants who are passionate to work on the SRI Technology of cultivation. It will enable the experienced SRI Practitioners to reflect upon the various economic aspects. It will also give an understanding of the requirements of the poor at the individual, household and community levels. This training will cover the Practical aspects at all the three levels – conceptual, practical and reflective levels.

- ✓ On Farm Weeder Application and Maintenance
- ✓ Input Management and economics of Cultivation
