Call for Papers for National Workshop on Impacts of Watershed on Poverty Alleviation (During January 21-22, 2011)

The Centre for Water and Land Resources is organizing a 'Two Days' National Workshop on "Impacts of Watershed on Poverty Alleviation" during January 20-21, 2011 at National Institute of Rural Development, Hyderabad 500030.

Background:

In India, more than 60 percent area falls under arid and semi-arid zone where watershed intervention taken as a panacea. Given the socioeconomic context of the areas, the key program beneficiaries are the landed gentry, small and marginal farmers. The land less and other section of the poor are having fewer stakes in the watershed area. How to magnify the sustained gainful benefits in equitable manner to them is posing great challenge. Government of India has launched various programmes for livelihood generation and poverty alleviation through wage employment. Simultaneously, the conversion of wasteland and degraded land into arable land under the watershed programme is also going on, which brought about some visible changes. But, the effectiveness of these programmes on the poor is still a big challenge to drastically reduce the poverty in rural segments. Convergence is one of the approaches which GOI is effectively trying to bring in various programmes. The workshop envisaged to bring some tangible outcome for further intervention.

Issues: The following are the some of the issues identified where focus will be made to discuss further.

- Effective linkages between watershed development and rural livelihoods, Livelihood and impact on poverty.
- Type and nature of benefits flow accruing to various sections of the community
- Challenges in making the watershed program pro-poor and sustaining it in the long run
- Post project management and its impacts on poor
- Convergence of MNREGA and other programmes
- Public-private partnership (PPP) in watershed implementation for poverty alleviation.
