Photography is a great way to raise awareness on crucial issues that affect everyone. It allows for a different manner to approach and understand the topic.

Water and food are key to human life and both encourage good health, economic growth and social development. However, both water and food faced scarcity and access to either is becoming more difficult and problematic. Corruption can arise throughout many instances of the food production chain, even more so for water for food production as this adds to the complexities and different types of stakeholders involved.

This photo competition seeks to explore the relationship between water and

food, with a specific focus on integrity or corruption risks. We ask contestants to send us photographs that represent or conceptualise the damaging effect of corruption in water for food or that highlights transparency, integrity, participation and/or accountability to avoid corruption in water for food. All submitted photos must be associated to the issue of water for food or water and food security linked to integrity, which must be explained through the caption or a short description.

### Terms & Conditions

1. Each entrant may submit up to a maximum of 4 photographs, in digital formats (JPEG/GIF/BMP).
2. Each photo must be accompanied with a short caption (up to max. 30 words).
3. By entering the competition, the entrant represents, acknowledges and warrants that the submitted photo is an original work created solely by the entrant and that no other party has any right, title, claim or interest in the photograph.
4. By entering the competition, the entrant assumes, privately, personally and exclusively, all civil/criminal liability related to people, animals and/or objects depicted in their work, resulting from the concept, creation and marketing of their image and releases any such liabilities from the Water Integrity Network, its institutional partners and any other publishing or marketing body related to the promotion of the competition
5. By entering the competition, the short-listed entrant grants permission to the Water Integrity Network (WIN) to use and reproduce their photos at any such time and for any such means as it desires, without any limitation on space, time-frame, language, quantity of copies and quantity of usage, by way of the

media, formats and channels which it has approved including but not limited to: newspapers, internet, media in general, reports, books, posters, banners, in whichever venue, conference, seminar, national or international display, or by other materials and media of any nature, provided that the photos are correctly credited to their photographer (the entrant).

6. All entrants authorise the Water Integrity Network to use their image, name and personal details in photos and advertising spots and by whichever type of media and promotional material, for publicising the results of the competition.

7. The competition is open to general public, however WIN and Transparency International staff members, or their relatives may not apply
